- No saw tooth or unique clip hangers. • Worn, scarred or damaged frames are not acceptable. • Frames must be properly wired and ready for hanging. • All drawings, works on paper, watercolors and photos must be under glass or Plexiglas. • Clamped or cracked glass is not acceptable. • Work not ready for hanging or display will not be accepted. • Q Gallery Committee has the final discretion of artwork that will be displayed in the show. • Work must be completed in the last three years.

PLEASE NOTE: As a member of QAA and an exhibiting artist in our gallery, you will be obligated to sign up to gallery sit when you deliver your work. A minimum of 3-5 hours a month is requested, preferably during your exhibit.
